Hereby declare:

- 2. The participant's health allows them to take part in the RUNMAGEDDON event in formula*
- 3. During the event I will adhere to any orders or instructions from the Organizers or their Representatives, including volunteers, medical services, and emergency services.
- 4. Participants of the RUNMAGEDDON event take the risk and expose their bodies to extreme pressure according to their own will. I am aware this is an obstacle race. The Participant can overcome them, but doesn't have to. In case the Participant decides to deal with an obstacle, I understand there is a higher risk of injury, including bruising, spraining, dislocating, and bone damage, as well as insect bites and exposure to cold and any inconveniences that are to be expected during this type of event. I declare I take full responsibility shall any of the aforementioned injuries happen.
- 5. I agree to the processing of my and Participant personal data for the organization of the RUNMAGEDDON race by Extreme Events Sp. z o.o. based in Warsaw in accordance with the provisions of generally applicable law. I agree to the publication of Participants' first and last name in reports from the RNMAGEDDON race.
- 6. I hold full and exclusive responsibility for any harm done to anybody by the Participant during the event or during any activities concerning the training.
- 7. In case of an injury of the Participant, neither I nor the Participant shall demand any compensation from the Organizers, their Associates, and Volunteers working at RUNMAGEDDON. I hereby declare the Organizers, their Associates, and Volunteers are free from any responsibility for harm I or the Participant may experience during the RUNMAGEDDON event.
- 8. The personal information and declarations I provide are completely true. No piece of information about the Participant's health that could in any way be important for the even has not been omitted.
- 9. All potential disputes concerning the participation in the RUNMAGEDDON event will be resolved by the common court of local jurisdiction.
- 10. I am familiar with and I accept the terms and conditions of RUNMAGEDDON (https://www.runmageddon.pl/regulaminy).
- 11. I have been informed about my right to leave personal belongings not exceeding the value of 500 PLN in a deposit. I am familiar with and accept the rules of using the deposit. (<u>https://www.runmageddon.pl/regulaminy</u>).
- 12. I am aware the RUNMAGEDDON event will be filmed with a drone camera. The pilot has knowledge and technical capabilities to ensure safety. In case of a mistake or technical difficulties I will take precautions and not touch or come near the drone and the Participant shall do the same. In case of the drone falling I will make sure the Participant keeps their head safe. I relinquish any potential claims concerning the drone.

IMAGE - Information:

The race will be filmed and photographed and there exists a possibility your image may be used. Publishing the participants' image is used for promoting physical activity and convincing others to also participate in such events. Photographs and recordings are done in a spontaneous manner by hired people that can't choose specific people to capture. Their goal is to present the most interesting moments of the race regardless of which participant is visible.

The publication of participants' image is based on the permission of the filmed or photographed person. Such permission is specified in art. 81 act 1 sent. 1 of the copyright law and neighbouring rights. The permission to publish one's image is a declaration of will as it is understood in art. 60 of the civil code. Declaration of will – the permission to publish one's image cannot be freely withdrawn after the conclusion of an event. According to art. 61 § 1 sent. 2 of the civil code states that a permission can be withdrawn if it has been delivered at the time of signing this document or earlier.
