PARTICIPANT DECLARATION

I,, hereby certify that:

- I. I am of sufficient legal age to conclude an agreement . I am not under the influence of alcohol or any non-prescription drugs that may exclude me or limit my psychosomatic abilities and will not let me make decision.
- II. I confirm that I am in good health to safely participate in RUNMAGEDDON SAHARA on 20–26 March 2020.
- III. During RUNMAGEDDON SAHARA I will obey any rules and instructions given by the organizer or the team as well as by medical and rescue teams.
- IV. I participate in RUNMAGEDDON SAHARA at my own risk, I acknowledge that the event is an intense test of my physical and mental limits. I am aware that RUNMAGEDDON runs are events of increased risk during which I can suffer injuries such as scrapes, bruises, sprains, cuts and fractures as well as bites, hypothermia and any discomfort connected with such events and therefore I declare that I am completely responsible for the mentioned above.
- V. I fully understand the risks involved in the event and assert that I am willingly and voluntarily participating at my own responsibility.
- VI. In case of any injuries I hereby release, covenant not to claim, and discharge the organizer, RUNMAGEDDON SAHARA team and the other parties from any and all claims that I may have arising out of my participation in RUNMAGEDDON SAHARA.
- VII. I confirm to state only true data in this declaration. I confirm that I have no known or knowable physical or mental conditions that would affect my ability to safely participate in RUNMAGEDDON SAHARA.
- VIII. Any claims resulting from the data stated in this declaration, my participation in or connected with my participation in RUNMAGEDDON SAHARA will be settled by the common court of general jurisdiction.

- X. I also grant Extreme Events Sp. z o.o. located in Warsaw the permission to use my personal data in accordance with common law rules for the purposes of RUNMAGEDDON SAHARA race organization.
- XI. I am aware that the participants struggles will be filmed by drone. The drone’s pilot is experienced and qualified to perform such flights safely. In case of any mistakes made by the pilot or damage of the drone I will take any safety precautions and will not touch or get close to the drone. In case of fall of the drone I will protect my head.
- XII. I want to participate actively in RUNMAGEDDON SAHARA run and I declare that I am aware that fact that consequently I might be photographed or filmed and these might be published as the event coverage. I agree for using my photographs, motion pictures according to the information below which I fully understand and accept:
Pictures - information:
The whole event is photographed and filmed hence you can be on some of the recordings. Publishing pictures of the participants serve as a tool for sport popularization and to enhance others to join our next events. Pictures and movies are taken in motion by truly dedicated photographers/ cameramen who focus on interesting and catchy shots not on a person. Submitting the pictures is upon receiving a permission from a photographed person, specified in the art. 81 § 1 (1) of the Act on Copyright and related right. Authorization of the copyright owner to allow distribution of the pictures is a declaration of understanding the art. 60 of the Civil Code. The declaration of authorization cannot be cancelled freely afterwards and when the event is finished, as acc. to the art. 61§ 1 (2) of the Civil Code, the cancellation is effective only when it is presented together with the declaration or earlier. The processing of personal data (your pictures) according to GDPR is done through recording of the sport event basing on art. 6 § 1 (f) of GDPR according to which: the lawfulness of processing of personal data is ensured only when it is legally justified for purposes performed by the administrator or third parties. The Organizer has fully justified their business in sport popularization through submitting movie and photo coverages after sport events.
